The Architectural Centre appeals part of a decision on the following matter:

Plan Change 81: Rezoning 320 The Terrace and de-listing the Gordon Wilson Flats

The Architectural Centre received notice of the decision on 19 May 2016

The decision was made by Wellington City Council

The Centre is not a trade competitor for the purposes of [section 308D](#) of the Resource Management Act 1991.

The part of the decision that we are appealing is:

The decision to amend the District Plan to de-list Gordon Wilson Flats as a Heritage building (removal from the Heritage List (Chapter 21 appendix))

The reasons for the appeal are as follows:

The decision:

- a) incorrectly evaluated the historic heritage values of Gordon Wilson Flats as moderate, rather than significant.
- b) failed to have sufficient regard to the existing WCC District Plan listing of the Gordon Wilson Flats,
- c) had no proper basis to conclude that the WCC's 2012 heritage assessment (which reconfirmed the heritage listing of the building) was incorrect and inconsistent with the significance of other listed items.
- d) gave little or no weight to expert evidence which disagreed with the Applicant's heritage evidence and little or no weight to submissions from submitters with expert qualifications.
- e) was contrary to Regional Policy Statement Policies 21, 22, 46
- f) failed to put appropriate weight on the strong direction in RPS Policy 21

- g) failed to properly apply the criteria for significant historic heritage as set out in RPS Policy 21
- h) confused the consideration of whether to retain the current heritage listing of the building with the consideration of whether to permit demolition of the building, and, consequently wrongly took into account irrelevant factors (including: lack of reasonable alternatives to demolition, adverse heritage effects of adaptive re-use modifications, and the financial costs of strengthening and restoration) when deciding whether or not to retain the heritage listing of the building.
- i) placed over reliance upon the s 32 report and failed to evaluate the Plan Change against s32 matters.
- j) wrongly treated s74 as inapplicable

The Centre seeks the following relief:

1. The quashing of those parts of the decision relating to the de listing of the Gordon Wilson Flats. In particular:
 - a) the removal of the Gordon Wilson Flats from the WCC DP Heritage List in Chapter 21 and the removal of the heritage notation "299" in DP Map 16.
 - b) the insertion of reference to the demolition of Gordon Wilson Flats within WCC DP 9.2 "Controlled Activities in the Institutional Precinct" provisions.
2. Such other consequential relief as the Court may find appropriate including the quashing of the entire Plan Change.
3. The costs of this appeal.

- (b) within 20 working days after the period for lodging a notice of appeal ends, serve copies of your notice on all other parties.

You may apply to the Environment Court under [section 281](#) of the Resource Management Act 1991 for a waiver of the above timing requirements (*see* [form 38](#)).

Your right to be a party to the proceedings in the court may be limited by the trade competition provisions in [section 274\(1\)](#) and [Part 11A](#) of the Resource Management Act 1991.
